Ronald McDonald House

The Ronald McDonald House (RMH) Keeps Family Close when they need it most by providing a temporary "home away from home" for families who must travel to Las Vegas to receive critical medical treatment for their children. The House accommodates up to 12 families and 72 family members at one time. Families have their own bedroom suites with private bathrooms, play areas for the children, an adult respite room, a fully stocked pantry and laundry facility, lounge areas, and backyard. The House provides home-cooked dinners, healthy sack lunches, and rides to the hospital every day. We ask for a \$10/night donation but no family is ever turned away due to an inability to pay. In 2016, the House served more than 200 families for

RMHC Scholarships

RMHC awards college scholarships to deserving high school seniors and continuing college students from Clark and Nye Counties who demonstrate a financial need and who might not otherwise have the opportunity to receive a higher education. These scholarships are funded, in part, by proceeds generated through the sale of newspapers in McDonald's Restaurants. Local McDonald's owner-operators also conduct an annual restaurant fundraising event called "Eggs for Education." In addition, community partners contribute funds that are matched by RMHC Global. 150 high school seniors and returning college students were awarded more than \$369,000 in scholarships in 2016. Since 1999, more than \$4.1 million has been awarded

Lunch Is On Us!

In an effort to help relieve the financial and emotional stress of having a child in the hospital, RMHC volunteers prepare and deliver free healthy sack lunches to families sitting at the bedsides of their children at Sunrise Children's Hospital, University Medical Center, and the Cure 4 The Kids Chemotherapy Treatment Center in Las Vegas. More than 37,000 lunches in brightly decorated bags were prepared and delivered to families in 2016. Toys, books, and other children's activities are provided on occasion as well.
